	There was a discussion about how to effectively respond to the consultation and ensure all concerns are raised with the LA. The LGB felt that the process has not been managed well and the costs not fully

explored. It was also felt that any local petitions should be formally fed into the consultation process.

It was agreed to engage fully with the process and have all interested parties – parents, school, Trust and LGB submit their reasons why this change is detrimental to all and present a united front.

A potential solution to the reorganisation was discussed:

- Two middle schools and one upper school join the same Trust.
- Deficit at Wadham could be paid off
- Less disruptive and better for pupils.
- PLE has invited CW, MW (Swanmead) and MG (Wadham) to a meeting but MG has not responded. There is a thought to put this option out to parents.

## 3 **CEO Reporting Requirements**

- 3.1 Head Teacher Report:
  - Challenging term with pandemic and re organisation of South Somerset schools
  - Acknowledgment that staff have done a fantastic job in difficult circumstances
  - Staffing changes listed in report

- Covid plans have been successfully implemented. We have had one positive case but fortunately this did not impact greatly.
- School reorganisation has been discussed earlier.
- SEN Leadership Although we are getting excellent support with SEN from the Trust as a matter of priority we need to recruit an excellent substantive SENCo as soon as possible.
- Leadership team will, from Jan 2021, be reduced from five to two. This places additional pressure on the Head and Deputy Head teachers, especially at a time of potential change. PLE may have a couple of people able to assist until Easter and we have had a number of colleagues here offering to 'step up'.
- Ofsted we are due a section 5 inspection when these resume. As SEND is likely to be an inspection focus, we are very vulnerable to being judged 'requires improvement' if we do not address this issue as a matter of urgency and implement a successful plan. The

reduction of leadership capacity adds to the challenge of achieving a 'good' judgement. This could also put us in a weaken position with the South Somerset reorganisation.

It was asked what support has been given by the Trust We have EW coming one day a week and today EW and AB have held 3 SEND meetings. We also have JB from Stanchester supporting us by assisting first school transitions. We would not be in a good position without the support of the Trust.

It was asked would there be anyone from the Trust who take this role on

Although the Trust support has been fantastic we need someone here on site every day. However, it is difficult to recruit in the current circumstances.

## 3.2 ADP

We will be having a review meeting for the ADP in January. When it has been rag rated CW will forward out to Governors.

Action CW to forward ADP out to Governors after review meeting in January

CW highlighted that the fourth priority - Reading: To ensure all children have a reading age that is no more than a six months below their chronological age was achievable.

#### 3.3 Pupil Premium Evaluation

CW advised this was not available at this time. We have been using GL assessment testing and have invested funding into staffing. We will analysis the data and put strategies into place.

The profile of the school is changing: Percentage of pupils with PP funding:

- Year 8 16%
- Year 7 18%
- Yr 6 22.73
- Yr 5 31.78%

As you can see it is increasing, but compared to DfE national figures we are below average apart from year 5.

- FSM also indicates an upward trend.
- SEN register has increased, although it was noted that year 5 showed a lower percentage at 15.89.

CW advised there is £32K catch up funding available and when the data has been analysed, we will implement strategies to support pupils in catching up.

## 4 MBA Statutory Reports

- 4.1 Behaviour and Exclusions
  - There has been a marked increase in exclusions across the secondary schools in Somerset but MBA has bucked this trend.
  - The number of exclusions has fallen from nine to two and the total of days lost from exclusion has significantly dropped from 23 to three.

It was asked whether there was a pattern with the exclusions– subjects, pupils or just random. CW advised we can drill it down but unfortunately it is likely to be male SEN pupils.

 12 children (2.9%) have received one or more exclusions. When bench marked against the 2019 data, there has been an overall improvement.

Governors were pleased to see the trend of figures was positive.

#### 4.2 Attendance

- Whole school attendance figure is 94.55% this compares well to national figures, which are averaging just below 90%
- Breakdown for year groups shows positive data.
- 8 pupils have not returned to school due to Covid 19.

### 4.3 SEN

Signed.....

- EM, AB and Elsa Carreras (Trust Ed Psych) spent all day (26/11) in school assessing children, gathering information and speaking to parents.
- AB has been in contact with county with regards to consultations whose deadlines had been missed. These are now being completed.
- Helen Moore, Trust counsellor, has been completing dyslexia assessments
- Staff training four areas to be covered as set out in report.

A Governor was concerned about the amount of pressure on HT and SLT. CW advised he has received support from colleagues and MWG is also helping out.

4.4	Safeguarding

•	Number of pupils being persistently absent (below
	85%) is 8%. This is below national average.

- One allegations against a staff member but this did not proceed any further.
- Domestic violence abuse notifications have increased to one or two a week. We receive the notifications by police.
- 10 racists incidents
- 7 homophobic incidents

• 32 Peer on peer abuse needs unpicking. We realise we need to do more on combating these incidents and take a stronger line however it is encouraging to see that we are creating a culture that people will talk to us more.

• There were three actions identified through the completion of the 2019/20 Somerset Governors' Safeguarding Audit.

DW advised the safeguarding forum had been very useful and informative. DW also offered help in safeguarding capacity as her training was valid and up to date.

CW thanked DW for the offer and would discuss this with SP as unsure about the level of access that would need to be given to DW and sight of some very confidential sensitive information.

**Action** – CW to discuss with SP whether DW could assist with safeguarding due to level of sensitivity.

Anti-Bullying Policy
