## 1. <u>Procedural Matters</u>

1.1 Apologies for Absence

The HT shared that a member of the local community had approached her about becoming a Governor. The HT will meet with him and then feedback to PLE for next steps.

1.5 Feedback from Governance Review

CW summarised the findings from the report:

- Fair reflection of the meeting
- Contributions largely made by the Chair. More direct prompting of Governors might be useful moving forwards.
- HT to provide a verbal summary of the main points contained in the papers. This will ensure that more time is dedicated to scrutiny and discussion.
- Encourage more diversity onto the LGB

#### 2. CEO Reporting Requirements

2.1 Head Teacher Report

CL gave highlights from the report:

- The phonics screening threshold mark of 32 has not changed for 9 years. CL very pleased with results as huge amount of work has gone into this area and in the last four years only 1 child did not pass but did have SEN's.
- Yr 6 writing has been moderated and there was only one query on a greater depth pupil who will be remoderated. We will know the outcome of this in due course but CL/BM confident that the supporting evidence sent off will be sufficient for a GDS outcome
- English Hub have supported us with training and funding.

**Action** – CL to share English Hub report on Phonics with Governors at next meeting.

It was mentioned that MD has made huge progress and Governors were so pleased to see with her development. CL agreed in the last four years MD has thrived. The Chair felt sharing a pupil and teacher's progress would be a good case studies for Ofsted.

The Chair asked for their thanks and congratulations be passed onto the whole staff team.

It was noted that the presentation given at the parents stay and play day was very good as it was aimed at all years.

## Other updates

- Jubilee day was fantastic
- Parental survey only a couple of issues that will be resolved.
- Competitive sports have resumed.

It was mentioned that the children's behaviour when representing the school is exemplary.

 Safeguarding – 23 concerns raised compared to 17 last year.

It was asked if many of the concerns were repeated from last year

CL advised the current number represents 14 different families but some are from last year. Staff are being vigilant and this is showing in reporting.

It was noted on the main Safeguarding report the areas of highest need was not completed for term 3.

CL advised the data was last updated in April so this figure is not reflective of the 23 concerns highlighted. CL also advised upon reviewing the numbers in each of the categories it did reflect work that has been undertaken in school perhaps through assemblies which have prompted teachers/pupils to report concerns.

CL shared there are regular meetings with SP, Trust Lead, and AP, safeguarding Governor.

AP confirmed Pupil voice had shown that questions raised related to initiatives that have taken place in school.

It was felt useful for the SEN Governor carry out a SEN Pupil voice exercise.

 SEND – 4 children with an EHCP. There is 1 additional EHCP pending for a pupil. We are also gathering information for another pupil.

There was a discussion on the arrival of a new Ukrainian family into the school and some of the issues for them were highlighted such as language translation. Governors were keen to understand the measures and support that is available for the family but disappointed there is limited government help.

CL

It was asked what support there is available for them during the holidays

It was asked how many families coming from the Ukraine are in schools across the Trust.

CL was unsure of exact figures but advised PLE is looking into what support can be offered Trust wise.

**Action** – CL to look into what support is available for this family during the holidays.

#### 2.2 ADP

CL advised the ADP and SEF documents were for information. Governors will be updated on progress but there will be new documents for September 2022. Writing will be a focus for the coming academic year. CL raised concern about attendance and outlined what measures would be taken in the coming months.

It was asked how much of the figures are affected by Covid

CL advised there was a change in coding from X to I in Jan 2022 which will impact on numbers. However, we are above national which is 91.5% but we have 16 children with attendance at less than 90% which equates to 20% of the school.

The Chair felt most holidays that had been cancelled due to Covid should now have been taken and the school and HT have been more than supportive with families.

## 2.4 Primary Data predictions

- EYFS Combined 67%
- Year 1 Phonics 91%
- KS1 Reading 67%; maths 78%; writing a concern at 44%.
- KS2 results good very pleased as some pupils have made great progress since KS1 results.

It was noted a Governor had come into school to monitor the KS2 exam procedures were followed. A report will be made available on Trust Governor

BM shared how the plan was devised. It has been a little derailed at times, but we are back on track and another plan has been formulated for next year.

We are looking at how we can align the curriculum with the different year groups.

## 3. Update on Great Growing teachers/staff

CL advised the focus of GGT was on mathematics and parental engagement.

We have instigated various initiatives to achieve this:

- Stay and play session
- Keeping parents informed of child's progress
- Having face to face parental sessions
- Rag rated data sent home

These have all been well received by parents

It was asked if parent workshops would be instigated Yes would like to start them up now we are able to.

## 4. Policies – for information
